COLORADO MILITARY ACADEMY 2026–2027 ENROLLMENT TIMELINE

(Adopted by the Board of Directors – 11/18/2025)

This Enrollment Timeline has been developed in accordance with Colorado Revised Statutes (C.R.S. 22-36-101 et seq.), the Colorado Department of Education, District 11 Open Enrollment Policy (JCA/JFB), and the Colorado Military Academy Enrollment Policy (JFBA-JFBB, Revised November 18, 2025). It establishes transparent and equitable enrollment procedures for all PK–12 students, defines open enrollment and lottery windows, and outlines the Universal Preschool (UPK) process administered by the Colorado Department of Early Childhood (CDEC).

I. Universal Preschool (UPK) Enrollment — Pre-Kindergarten (4-Year-Olds Only)

Enrollment for preschool students is managed through the Colorado Universal Preschool (UPK) system administered by the Colorado Department of Early Childhood (CDEC). Families must apply through the state portal at UPK.Colorado.gov.

Note: After completing the UPK application and being officially matched with Colorado Military Academy, parents/guardians are required to complete the CMA Registration Process as outlined in the Enrollment Policy (JFBA-JFBB) and Enrollment Timeline. This step finalizes the child's enrollment and secures their placement at CMA.

March 2, 2026 Enrollment Lottery CMA conducts its public random lottery for oversubscribed grade levels. Priority is applied per CMA policy: (1) children of staff

(not to exceed 10%), (2) siblings of current students, (3) siblings of newly accepted students, and

(4) all others.

enrollment offers or waitlist status in their preferred language and communication

method.

March 9 – March 13, 2026 Lottery Acceptance Window Families must accept their

enrollment offers within five (5) business days of notification. Failure to do so will result in forfeiture of the offered seat.

Choice Enrollment Closes Final date for new K–12

applications and waitlist movement for the 2026–2027 school year, aligned with the state's October Count. After this date, only out-of-state transfers

may be considered for

enrollment.
